### Checklist for Application

This program provides monetary incentives for commercial electric customers of the East Grand Forks Water and Light Department to upgrade the lighting in their facility to more energy efficient fixtures.

### What products are eligible for the rebate?

- Please see the lighting table on the following pages for information on the eligible products.
- If your lighting replacement project does not fit one of the prescriptive measures on the following pages, it may still qualify for a rebate. Please contact the Department at 773-1163 for custom lighting project review prior to beginning the project.

### General Qualifications

- Fill out the Rebate Application including the Rebate Calculation Tables and Worksheet. Incomplete and/or illegible applications will not be processed.
- Lighting equipment must be operated during weekday on-peak demand hours (6 am – 9 pm) except exterior fixtures
- Customers must apply for rebates within 1 year of the purchase date shown on the equipment invoice.

### Application

- Submit completed application along with copies of dated invoices specifying the quantity, price, manufacturer and model # of all materials purchased.
- Rebates over \$200 will be paid in the form of a check to the customer

### Inspection and Verification

The Department reserves the right to conduct an inspection of the site after installation to verify that all the program rules and requirements have been met. If the Department finds that the customer has not met its rules and standards, any rebate the customer has received must be returned to the utility.

### Rebate Limits

- Rebates cannot exceed 50% of the total project cost.
- Rebates are processed on a first-come first-serve basis
- Rebate qualifications and amounts are subject to change at any time. The Commercial Lighting Replacement Rebate Program will stay in place each year unless amended or eliminated.
- The Department will not rebate for the same installation more than once during the expected life of the installation
- The Department reserves the right to limit the maximum amount of rebate per facility/customer in any one year depending on the Department's Conservation Budget.
- The Department does not guarantee that the installation of high-efficiency material or equipment will result in reduced usage or demand or in cost savings.
- The Department makes no warranties, expressed or implied, with respect to any material or equipment purchased and/or installed, including, but not limited to, any warranty of merchantability or fitness for a particular purpose. In no event will the Department be liable for any incidental or consequential damage.
- The Department will not be responsible for any tax liability imposed as a result of the rebate payment. Customer are advised to consult their tax advisor
- The Department is not liable for rebates promised to a customer as a result of a contractor misrepresenting the program.
- *The Department has set a 10 year maximum rebate, when combining all Commercial Rebates, at \$100,000.00 per facility.*
